## Nashville Dog Training Club Trial COVID-19 Rules

Due to the ongoing COVID-19 pandemic, the following rules will be in place during the trial.

While we are doing the best we can to make this event as safe as possible, there may still be risk of infection/exposure that we don't know about or cannot control. If you are concerned about the possibility of exposure to the coronavirus OR if you are unwilling to follow the stated rules, it would be best if you did not enter this trial.

We realize these are changes to activities and habits we have had for a long time. We would all be happier to go back to what we knew as normal. Hopefully in the future, we can do that.

In the meantime, in order to hold this trial, these are the compromises we must make, based on information from the CDC and following consultation with the AKC. Please be aware that infractions of these rules will be dealt with according to AKC regulations, up to and including requiring you to leave the trial site and bench committee hearings.

**Illness – IF YOU ARE ILL, DO NOT COME!** If you have been exposed to someone who has tested positive for COVID-19 in the last 14 days – **DO NOT COME!**

Changes to rules – We may make changes to these rules prior to the start of the trial. **BE SURE** to read your confirmation letter to see what changes have been instated.

## Refunds

Entry fees shall not be refunded in the event that the dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee. If because of riots, civil disturbances, or other acts beyond the control of the Club it is impossible to open or complete the show, no refund will be made. The club may cancel the events due to extreme weather conditions.

No entry fee may be returned after entries close, except that of a bitch that comes in season after being entered or an injured dog. A refund less a \$5 per entry to cover expenses will only be issued if the Trial Secretary receives a veterinarian's Certificate or letter to this effect at least ½ hour prior to the start of classes. No refunds for overpayment of fee will be made for amounts of \$5 or less.

**4 rings** - 1 will be a go-out ring only. Other rings will be a novice, open, utility. **Rings** will be monitored but judges/stewards will not be provided.

**Cost** \$10/10 minutes. Payable when signing up – no sign-up before 1 pm and no refunds.

**Only 1 slot per person per ring** will be accepted until everyone has signed up, and then additional sign-ups will be taken. For example: one person may sign up for 1 slot in the Open ring and 1 slot in the utility ring, but may not sign up for 2 slots in the utility ring until after everyone else has had a turn.

Verbal corrections, gentle guidance and toys will be permitted.

No food will be permitted in the rings.

## **Important information about early crating and setup --PLEASE READ!**

The building will be open for crating at **1 pm**. For the Club to ensure there are plenty of workers to unload the equipment trailer, we will allow early crating for workers who help with unloading and ring set up. We know that some people like to drop by the trial site early to set up their crating areas, but don't have the time or ability to help with the trailer unloading and ring set up. NDTC will once again allow early crating for a fee of \$10 per mat.

If you want to setup your crates early and you cannot stay to help unload the trailer, you will be charged \$10 per mat that you put down. Early crating time will **be 11:00 AM – 1:00 PM. Unloading/setup will begin at 1 PM.**

### JOYCE GARMAN MEMORIAL TROPHY

The Joyce Garman Memorial trophy is awarded annually in loving memory of Joyce Garman, a longtime member of NDTC and competitor in obedience and agility.

This trophy will be awarded to a dog with an agility title who wins the single highest score in a regular obedience class (Novice A or B, Open A or B, Utility A or B) over the course of the four-day trial.

This trophy (a large pewter cup) must be won three times by the same handler for retirement of the trophy. The handler's name and year of award will be inscribed on the trophy, which will remain in possession of the NDTC until retired. The dog and handler will be given a 7-inch pewter plate to commemorate their win.

### Jump Heights

All Rally and Obedience classes will be run in following order (except to accommodate handlers with multiple entries) each day. Rally Jump height is required for Advanced, Excellent and Master classes.

**Thursday:** Low to High, beginning with lowest jump height  
**Friday:** High to low, beginning with highest jump height  
**Saturday:** Low to High, beginning with lowest jump height  
**Sunday:** High to low, beginning with highest jump height

The club will allow transfers – refer to Rules and Regulations, Chapter 1, General Regulations, Section 16a.

- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. NDTC reserves the right to rescue any dog that may be in distress in a vehicle and be held harmless for damage to the vehicle.
- No alcoholic beverages allowed at the show site.
- All dogs must be on leash except when in the ring.
- Trophies/Awards not particular to a specific class will only be awarded after all scores have been turned in to the Trial Secretary. No trophies/awards will be mailed.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause that the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. I (we) agree that any cause of action, controversy or claim arising out of or related to the entry, exhibition or attendance at the event between the AKC, the event-giving club (unless otherwise states in its premium list) and myself (ourselves) or as to the construction, interpretation and effect of this agreement shall be settled by arbitration pursuant to the applicable rules of the American Arbitration Association. However, prior to arbitration all applicable AKC bylaws, rules, regulations and procedures must first be followed as set forth in the AKC charter and bylaws, rules, regulations, published policies and guidelines.

INSTRUCTIONS

- 1. [Variety] If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, Parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. [Event Class] Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3 of the Rules Applying to Dog Shows).
