A written certification must accompany each entry for any dog that has not previously passed an AKC TD or TDU test. This statement must be dated within two years of the date the test is to be held, signed by either a person approved to judge tracking tests, or by a person/evaluator who has handled a dog to a TDX or VST title within the last ten (10) years, and must certify that the dog has satisfactorily performed a certification track.

In accordance with Chapter 1, Section 13 of the AKC Tracking Regulations, entries in this tracking test shall be accepted up until the official closing date and time, even though the limits may have been reached.

A drawing from all entries received will be held at the home of the Test Secretary at 7023 Bonnavent Drive, Hermitage, TN 37076 on November 22, 2023 at 6:00 PM CST to determine participants in the test. The public is welcome to attend the draw. Preference shall be given to those dogs that have not earned the Tracking Dog title. When the advertised limit has been drawn, all remaining entries shall be drawn and assigned a position on the alternate list.

All entries drawn to participate and all alternates will be notified of the outcome promptly after the draw. At that time, alternates will be given the option to accept or decline being placed on the alternate list. Those who accept shall be placed on the alternate list in the order in which they were drawn. Entry fees and certifications shall be returned in accordance with Chapter 1, Section 13 of the AKC Tracking Regulations.

Per Chapter 1, Section 17D, Test Worker Option, of the AKC Tracking Regulations, one (1) track at this test will be set aside for entrants submitting with their entry certification of prior participation at an NDTC tracking test. Test Worker Certifications will not be returned.

NDTC will offer an award for passing tracks.

Site ground cover consists of rolling fallow meadows.
