In accordance with Chapter 1, Section 13 of the AKC Tracking Regulations, entries in this tracking test shall be accepted up until the official closing date and time, even though the limits may have been reached.

A drawing from all entries received will be held at the home of the Test Secretary, 3195 Nashville Highway, Lewisburg, TN 37091 on Thursday, January 31, 2018 at 5:30 PM to determine participants in the test. Preference shall be given to those dogs that have not earned the TDX title. When the advertised limit has been drawn, all remaining entries shall be drawn and assigned a position on the alternate list.

All entries drawn to participate and all alternates will be notified of the outcome promptly after the draw. At that time, alternates will be given the option to accept or decline being placed on the alternate list. Those who accept shall be placed on the alternate list in the order in which they were drawn. Entry fees and certifications shall be returned in accordance with Chapter 1, Section 13 of the AKC Tracking Regulations.

Per Chapter 1, Section 17D, Test Worker Option, of the AKC Tracking Regulations, one (1) track at this test will be set aside for entrants submitting with their entry certification of prior participation at an NDTC tracking test. Test Worker Certifications will not be returned.

NDTC will offer an award for passing tracks.

Site ground cover consists of rolling fallow meadows interspersed with wooded areas.

Directions to site: From I-65 take exit 46 for US-412/TN-99. Go East on TN-99 approx. 20 mi. Turn right onto US-421-S. Go approx. 4 mi. Turn right onto US 31-ALT S. Turn left on Hwy. 69. Go to Hunter Road. Turn left. At fork, bear right onto Palmetto Cemetery Road. Site is first house on the left. Park at house and walk up drive to barn.

INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above.
